INTRODUCTION

The Nokukhanya Luthuli Resource Centre requires upgrades, and these include improving the appearance and the overall aesthetics of the building. These upgrades will be conducted on the different venues within the Resource Centre building including the auditorium, gallery, IT room, etc. The currently specified work to be conducted is in the boardroom.

The Luthuli Museum therefore seeks to appoint a professional and qualifying Service Provider with tinting, frosting and block out blinds installation expertise for the work explained below.

SPECIAL CONDITIONS

- 1. No sub-contracting will be permitted without the approval and consent of the Project Officer due to knowledge and experience required in order to render an effective service towards the tinting and frosting work.
- 2. Once appointed, no additional costs incurred by Service Provider will be accepted by the Museum. Therefore, all anticipated costs should be included in this quotation.
- 3. The successful Service Provider will be required to submit a Letter of Good Standing in terms of COIDA; or his/her latest assessment and proof of payment thereof; or proof of registration with the Compensation Commissioner (only in cases of a new registration), prior to commencement of work.
- 4. The Service Provider must take all necessary precautions to ensure that he/she complies in all respects with the environmental safety legislation and the Occupational Health and Safety Act (OHSA) aimed at protecting the health and safety of workers and others in the workplace.
- 5. The service provider will be responsible for the compilation of a health and safety site file to be made available for compliance and audit purpose. This also includes ensuring all staff deployed on-site to execute the duties are provided with Personal Protective Equipment (PPE).

DAMAGES

- The Service Provider shall inform the Project Officer of any damages caused by the specialist operations or testing, on the day that such damages occur.

APPOINTMENT OF A SERVICE PROVIDER FOR TINTING AND FROSTING INSTALLATION AT THE NOKUKHANYA LUTHULI RESOURCE CENTRE BOARDROOM AT LUTHULI MUSEUM

1. BACKGROUND AND DISCUSSION

1.1 The Luthuli Museum has identified and prioritized the need to appoint a suitably qualifying and experienced Service Provider to perform professional tinting, frosting and installation of block out blinds services at the Nokukhanya Luthuli Resource Centre Boardroom.

2. PROJECT DESCRIPTION

- 2.1 All existing frames in the Resource Centre building are made of aluminium.
- 2.2 The main entrance which has two (2) glass panels and requires tinting.
- 2.3 The internal partition panels (4) and doors (2) require frosting.
- 2.4 Four (04) staff offices doors require tinting
- 2.5 The Resource Centre and staff offices require installation of block out blinds

3. PURPOSE OF PROJECT

- 3.1 The purpose of the project is to provide external light reduction, privacy and elimination of distraction during meeting proceedings.
- 3.2 These installations will also improve the overall aesthetics to the boardroom.

4. SCOPE OF WORK

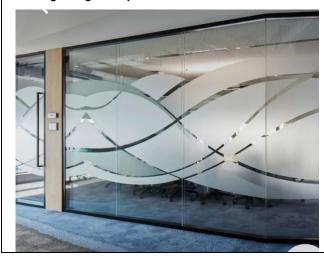
The role of the appointed professional Service Provider is to conduct the tinting, frosting and installation of block out blinds as per the specifications including confirming measurements provided on-site.

Below is the scheduled scope of works:

- 4.1 Supply and delivery 35% tinting material for the boardroom's main entrance panels, approx. 242cm high x 71cm wide each
- 4.2 Supply and delivery of 1.2m high frosting material for the boardroom's rear partition panels, approx.197cm high x 78cm wide each
- 4.3 Supply and delivery of 1.2m high frosting material for the boardroom's internal door panels, approx. 191cm high x 68cm wide each
- 4.4 Supply and delivery of 35% tinting material for the staff office main entrance door panels, approx. 183cm high x 69cm wide each
- 4.5 Supply and delivery of block out blinds for door panels, approx. 250cm high x 490cm wide each at the Auditorium
- 4.6 Supply and delivery of block out blinds for Auditorium and staff office window panels, approx. 57cm high x 149cm wide each
- 4.7 The required frosting height is 1.2m high, leaving a gap both at the top and bottom of each glass panel.
- 4.8 The preferred design will be discussed in detail with the appointed service provider.

 - The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
 - iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct:
 - iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have
 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the Bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the audi alteram partem (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
